Advanced standing information for SCU students studying at SCBIT

What is advanced standing?

Advanced standing (sometimes called exemption, credit, credit transfer or recognition of prior learning) may be granted for previous tertiary studies undertaken (normally completed within the last ten years) that are similar or equivalent to units in your SCU course. Relevant and current professional-level experience, skills or expertise may also be considered for undergraduate applicants only. Advanced standing provides you with a means to reduce the number of units you have to study in order to complete your course, saving you time and money.

NB: 'Rules Relating to Awards' and 'Specific Award Rules' for YOUR course are in the SCU Student Handbook (www.scu.edu.au/handbook/)

When do I apply for advanced standing?

You may apply for advanced standing when you apply for admission. Current enrolled students may apply at any time throughout their course.

Applications should be lodged at least one month before the start of the relevant study period. The earlier you apply for advanced standing, the better, as any advanced standing you are granted will affect the length of your student visa, your study plan and the units in which you need to enrol.

How do I apply for advanced standing?

You apply for advanced standing by completing this form and providing evidence to support your claim. Be sure to:

- Read the form carefully.
- Complete all relevant sections in full. Postgraduate and Bachelor of Business applicants cannot apply for advanced standing on the basis of professional experience or expertise.
- Print clearly and neatly, in English, using a black pen.
- Initial and date any change that you make to the form.
- Sign and date Part 3, DECLARATION.
- Attach supporting documents, (See below: 'What else do I need to provide?')

NB: Illegible or incomplete applications cannot be processed and will be returned with a request for further information or clarification.

What else do I need to provide?

You need to supply documents to verify your application. The University will use these documents to determine how your previous study and/or skills and experience align with Australian standards and with your SCU course. When applying for advanced standing based on previous study, attach the following:

Transcript(s) for completed or partially completed qualification(s) (including failures and an explanation of the grading system)
Detailed course and/or unit outline(s)

PLUS

Statement of Attainment for partially completed qualification(s) OR Testamur/Certificate for completed qualification(s)

When you are applying for advanced standing based on relevant and current professional-level experience, skills or expertise, attach:

Cover letter (stating why advanced standing should be granted)
Current résumé
Detailed statement of professional or voluntary service from current and/or previous employer(s), supervisor(s) or trainer(s).
(More than a reference, this document should appear on letterhead, contain the contact details of the organisation, display the date of issue identify and be signed by the issuer, provide details of length of service, full or part time capacity, role, and primary responsibilities.)
Position description and/or performance reviews listing key duties

PLUS (Where applicable)

Work samples such as a creative portfolio, design(s), project plan(s) (with evidence of outcomes) OR Record of workplace training or professional development, via 'Statement(s) of Attendance', Certificate(s) or professional development register

Please note: All documents submitted must be originals or certified copies of originals. Non-English documents must be translated into English by an accredited translation authority. Receipt of your application

Receipt of your application will be acknowledged in writing by post and/or email, therefore you must ensure that your contact details remain up-to-date with SCBIT. Currently enrolled students must also ensure their contact details are current in 'MyEnrolment'.

The assessment process may take up to one month, depending on the level of assessment complexity and whether sufficient evidence has been supplied. Following assessment, a written response will be provided by post and/or email which will approve or decline your application, or will request further information or documents. Where approved, advanced standing is conditional on us examining your original documents and on you acknowledging, in writing, your acceptance of the amount of advanced standing granted.
